SUMMARY: The Class A Driver is responsible for the transportation of product to and from the warehouse. This position will also occasionally assist with general warehouse tasks. This position works primarily with gas cylinders housing SF6, CF4, Xenon, Neon, etc. HazMat, OSHA, and Forklift certification will be provided.

DUTIES AND RESPONSIBILITIES:

- Drives a tractor trailer to and from port and parent company
- Load shipments efficiently and according to packing slips and safety guidelines
- Maintain cylinders, including cleaning, blasting, painting, and labelling
- Build orders: gather, record serial numbers, weight, etc
- Palletize, rack, or box cylinder(s) according to packing slip
- Is responsible for filling and emptying gas from various containers
- Ensures cylinders function properly, replacing valves and fixing stamps as needed
- Operate warehouse material such as forklift, industrial scale, and other machinery
- Communicate regularly with Warehouse Department manager and Director of Field Operations to ensure thorough understanding of all needs and priorities.
- Keep documentation of customer feedback and complaints.
- Maintain confidentiality around sensitive documentation.
- Cross trained in customer service-related tasks.
- Attends training to develop relevant knowledge and skills.
- Performs other duties as assigned by management.

Employees must have basic English proficiency in reading comprehension to ensure full understanding of all safety policies, procedures, and certifications for performing work in the warehouse and other areas that contain gas, chemicals, and equipment.
